JBLE RNEC: Help & Service Desk Operations

Bowhead resolved 15,395 service tickets, while also engaged with NETCOM directed network upgrades, such as NETMOD-C switch upgrade, Joint Regional Security Stack Migration, and Windows system upgrade. The ability to maintain required system support, and complete mandated system upgrades has ensured network and computing reliability for the JBLE RNEC.

NEC-RIA: Cybersecurity

In the six months following our NEC-RIA phase-in, Bowhead personnel identified 109,602 legacy security vulnerabilities and reduced vulnerability instances to just 250. Supported by our systematic approach to mitigating security vulnerabilities NEC-RIA was the first US Army site to pass DISA's more stringent CCRI inspection.

USACE GIS: Agile DevSecOps

Bowhead developed and sustains more than 200 cloud-based applications using a customer-tailored DevSecOps framework, realizing both system-wide security and mission objectives across an expansive enterprise ecosystem and diverse district-level toolsets.

NSWCDD RDT&E: Network Operations

To ensure compliance with the DISA STIG for Network Infrastructure (NI), Bowhead personnel implemented an 802.1X port-based authentication solution through the integration of Cisco Identity Services Engine (ISE). Our automated solution replaced the existing manual process, which was highly labor-intensive. As a result of our efforts, the Government saved considerable man hours previously needed to ensure compliance.


